Local Laws discussed:

- Local Law Amending Section 560-49 of the WHD Village Code, Application Procedures for the ZBA
  - Discussion want stenographer at all meetings, not at the board's request. Stenographer, attorney fees, consultant fees, should all be billed to the applicant. Variance fees to change to an application fee, plus a fee per variance

- requested.
- o Stenographer can bill per application, split the invoice to reflect cost for each applicant. Applicant to pay invoice prior to the building inspector issuing a building permit.
- SC Department of Planning response days amended to 45 days from 30 days.
- o Joe Prokop to amend the law.
