 - Proposed Local Law of 2015 Creating a Chapter 190 Clothesline.

Regulations of the Village Code of the Village of West Hampton Dunes Public comment period on Proposed Local Laws

- Richard Mueller, 687 Dune Road suggests making the rental season from Memorial Day to Labor Day, instead of what the currently the season, May 1- November 1. Mr. Mueller also suggests raising the rental fee to \$1,000 or \$1,500 per application. Mr. Mueller also commented on two rental homes at 819 & 915 Dune Road. Both advertise with 6 & 8 bedrooms.
- Attorney, Joseph Prokop Both houses need to be put on notice, with violations issued with 10 days to respond. Building Inspector will need to inspect both houses.
- Trustee Trimarchi there was a mistake in the drafting of the original rental law with regards to the period of time. The local law reflects no less than 30 day rental period. It should be no less than 2 week period of time.
- Trustees to review current rental law for modifications for the next meeting.
- Code of Ethics –section 63-18 Annual Financial Disclosure. This is not a mandatory requirement for a Village of our size, therefore, the Village Attorney is suggesting it be removed from the Village Code Ethics. The amendment of the Local Law will be voted on by the Board of Trustees at the next Village meeting.
- Trustees discuss and agree that there will be no new local law with regards to regulations of clotheslines in the Village.
