As per the engineer he did not see homes that were considered four stories. The Mayor instructed the Village Attorney to attempt to recover money spent on the Department of State in regards to the four story homes.
- The Village attorney does not see any headway being made with Suffolk County Attorney Brown so he has prepared the paperwork to file a case against the county in hopes that they will move along with the issue at 943 Dune Road. The Mayor believes that if the County is faced with litigation it may force them to take action

• 656A Dune Rd-Survey is complete and plans have hopefully been submitted to the state by Nick Vero. Landscaping will be done by the weekend. The village needs to bid the demo. The new house was put out to bid but there were no submissions. Contact Baymen Electric to take wires off the house. Demo house by August meeting.

Treasurer's Report:

- Angela to report back to work 7/22/19
- 92% of taxes have been collected. If they are not received by 7/1/19 a 5% penalty is added to the bill and 1% every month thereafter.
- Year end is being finalized with the accountant
- \$1100 in rental permits since 6/1/19

Village Attorney:

• Advises residents who are going to try for the variance in regards to their propane tanks to use application 2078. What was prepared for residents a year and a half ago was from the information that was provided for the village at the time. We have now been instructed to use variance application form 2078. All applications will require a survey with the propane tank location on it. If you plan on abandoning the tanks you must file for a building permit with the Village Building Inspector. Any residents who have not responded to the village's last attempt via certified mail to rectify their propane tank will

receive another certified letter to take action immediately. Any buried tanks must get a propane tank application.

Constables Report:

- If there is an actual emergency please do not call the duty phone call 911. Once 911 is called it will dispatch to the proper agencies including the constables.
- Rental permits are up and so far the summer has been good. If you are renting the rental permit number is required on all digital advertisements.
- There are 7 part time constables on duty this season
