1 Okay. I guess we could MAYOR VEGLIANTE: 2 waive the pledge of allegiance, but we don't have a flag. We'll just come to order. Everyone think 3 4 of the pledge of allegiance in your mind. 5 We have some public hearings that we have to attend to quickly, and then we'll talk about the 6 re-nourishment. 7 Okay. The first public hearing, this is the 8 9 first time to accept the public comment of a 10 proposed acquisition of an easement at 906 Dune 11 Road, over the barrier beach property, right? So 12 is it open? MR. DiCIOCCIO: Yeah, this is the first time 13 14 on, so it's just a hearing to consider whether or not there's a public purpose, and whether or not 15 16 there will be any potential impacts on the 17 environment. 18 MAYOR VEGLIANTE: Okay. MR. DiCIOCCO: According to the village 19 attorney, he's advised me that if anyone wants to 20 21 speak, they're more than welcome to speak, but 22 it's his recommendation that we adjourn the 23 hearing tonight, keep the hearing open, and let 24 them work on a proposed resolution. So that would be to the 25 MAYOR VEGLIANTE:

1 February meeting?

2

MR. DiCIOCCIO: Right.

3 MR. TABONE: What is it?

4 MAYOR VEGLIANTE: Chuck, it's been -- as you 5 know, there's a problem with the 949 easement for 6 the ocean. The problem is that the county never 7 properly conveyed it and there's not been a clear 8 record of title.

9 Greg Rinn, who is the owner of 949A, and the 10 Feeneys over at the house next door where the 11 easement lies, have been kind enough to make an 12 offer of dedication of that property. The county 13 has said if they dedicate the property, they will 14 approve the walkway and name it Number 7.

15 However, in an effort to maintain it, Greq Rinn would like, you know, an opportunity to 16 17 access the bay on the bay side at the BBPA 18 property. So he would request that we would be involved, as a combination of that property, use 19 20 of his walkway to the bay. Not for a dock, not for a marina, just for a walkway to the bay and 21 22 access to the bay side. I know you have some 23 interest in that.

24 MR. RINN: Well, I didn't know that this was25 on the agenda today.

1 MAYOR VEGLIANTE: It's -- well, it's on the 2 agenda tonight as an opening statement. MEMBER TRIMARCHI: We're not voting. 3 4 MAYOR VEGLIANTE: No, we're not voting. 5 MR. RINN: The last I had spoken to you, I thought Walkway Number 7 was in the correct place 6 7 and that the county had all the information they needed for that. 8 9 MAYOR VEGLIANTE: They've refused to 10 acknowledge that. They -- while we've proven to 11 them that they have it, they've refused to acknowledge it. They want more of a dedication or 12 13 a statement or they want us to maintain an 14 easement. So they want us to create the easement 15 for them and give it to them. 16 I think it's a real problem, but nobody wants 17 to take that battle, especially when that battle 18 was coming just before the sand was getting delivered. We didn't want anything to interfere 19 20 with that. So, you know, we have discussed this 21 as an opportunity to modify it. 22 MEMBER TRIMARCHI: We needed that sand. 23 MAYOR VEGLIANTE: I'm sorry? 24 MR. TABONE: I mean, Greg, you're here, so I don't want to talk around you. So what is your 25

Page 7 1 intention? I mean, obviously, you knew we were 2 not happy about what had been proposed. So what is your intention to do there? 3 MR. RINN: A small catwalk so I can walk out 4 5 and throw a crab trap out in the grass back there. There's been a path back there for years --6 7 MR. TABONE: Right. MR. RINN: -- just walking through the mud 8 is, you know, not too helpful. And it's for my 9 10 elderly mother-in-law, she likes to go crabbing. 11 So access back there. MR. TABONE: So that would be your easement? 12 13 MR. RINN: Yes. Just Feeney and me, just the 14 two of us. It's reciprocal because we're giving 15 up a property interest. 16 MR. TABONE: So it's not BBPA members or --17 MR. RINN: No, we're not going to have a 18 marina back there. I think that's what Gary was 19 trying to get to. 20 MAYOR VEGLIANTE: It wouldn't preclude the 21 BBPA from creating a use to the bay. 22 MR. TABONE: But not on that piece you're 23 talking about. 24 MR. RINN: Correct. 25 MEMBER TRIMARCHI: And they don't have the

1	funding to do anything like that, or will ever
2	have that.
3	MAYOR VEGLIANTE: I understand your concern
4	about the impact.
5	MR. TABONE: I mean, the impact, Greg, we
6	have no issue with you using the canal there. We
7	just have a problem with 300 people using it
8	there.
9	MR. RINN: This is, I guess, narrowly
10	tailored, we'll call it. And I've kayaked, I've
11	paddle boarded, it's kind of shallow and muddy.
12	MR. TABONE: It's shallow and muddy and
13	MAYOR VEGLIANTE: It is, you know, so I don't
14	foresee a problem, but we have a month to go on.
15	Do you see a problem?
16	MEMBER TRIMARCHI: You'll have to file it.
17	MR. RINN: Oh, yeah.
18	MAYOR VEGLIANTE: So I think it's the
19	MR. TABONE: Is the BBPA in favor of this?
20	MAYOR VEGLIANTE: The BBPA is in favor for us
21	to condemn it. They and I understand their
22	position, they don't want to be involved in
23	dedicating it. They would rather the Village
24	condemn it. It takes the heat off of them.
25	MR. TABONE: So then, the village condemns

it, grants as an easement to the homeowners to use 1 2 it? 3 MAYOR VEGLIANTE: Right. 4 MR. TABONE: The homeowners are granted an 5 easement for Number 7? MAYOR VEGLIANTE: No, the homeowners grant 6 7 the easement to the Village for the public access. See, that's the issue, we wanted to get this 8 9 done as cleanly as possible and make sure that 10 nothing impacts the project. 11 Also, Dr. Wang (ph.) who has been -- by a whole by the mistake that the county has made, 12 will get his property released from the town. 13 14 MR. TABONE: Does Number 7 get fixed? It's 15 falling apart. 16 MAYOR VEGLIANTE: It will get fixed. If they 17 don't, we'll get it done. But they're supposed to 18 be fixing it, the County. MR. TABONE: Well, we had this discussion 19 20 last year. 21 MAYOR VEGLIANTE: T know. 22 MEMBER TRIMARCHI: How much work? 23 MAYOR VEGLIANTE: The problem is we're 24 pushing the County as much as we can. 25 MEMBER TRIMARCHI: You're not going to get

1 nickle out out of them.

2	MAYOR VEGLIANTE: We got them to the do the
3	other one. We got them to do the easterly one.
4	The problem is to get this done, dedicated in
5	their records, and then we can press them to
6	repair it if they don't want to repair it. It's
7	not a big public it's not like a public
8	walkway, so we'll get it done. We'll get it done.
9	But we won't be voting on this until next
10	month.
11	MEMBER TRIMARCHI: Who's paying for it?
12	MAYOR VEGLIANTE: What?
13	MEMBER TRIMARCHI: The walkway.
14	MAYOR VEGLIANTE: The one on the bay?
15	MEMBER TRIMARCHI: Yeah.
16	MAYOR VEGLIANTE: Not us.
17	MEMBER TRIMARCHI: The homeowner?
18	MR. RINN: It's the homeowner side.
19	MEMBER TRIMARCHI: Are you what are you
20	doing? It's just going to be
21	MR. RINN: You just have to put wood chips
22	down.
23	MEMBER GOLDFEDER: You're going to have to
24	get a DEC permit.
25	MEMBER TRIMARCHI: They're not going to let

1 you put wood chips.

2	MR. RINN: You could actually see, I did in
3	my old old house in Remsenberg. If you cross
4	South Country Road and look to the west side of
5	the Speonk River, it's actually we gave our
6	old Southampton Town ran us ragged, we just
7	donated as a park there. And the only thing left
8	of my old house is the dock, and it's all
9	state-of-the-art
10	MEMBER TRIMARCHI: This is very specific with
11	the walkway on the bay side. You have to submit a
12	drawing, Aram can prepare the drawing and submit
13	it for you, and they're very detailed about what
14	they want. And they're coming down to look at it,
15	and I just got mine approved.
16	MR. RINN: Who did it? You recommend a
17	dock
18	MEMBER TRIMARCHI: Aram.
19	MR. RINN: He could do the Village?
20	MEMBER TRIMARCHI: Yeah. And I built it
21	myself. I built it with my guys.
