Public hearing opened at 7:42 pm for an amendment to the exterior construction law

Current law states the term "exterior construction" but does not specify what exterior construction is. The complaints are growing regarding construction on the weekend during the height of the season. The Trustees discussed changing the law to exterior noise that creates a disturbance. The Village Attorney is concerned that it is not specific enough and also recommends no commercial work at all on the weekends from May 15<sup>th</sup> to September 15th. The Southampton Town definition was discussed and taken into consideration. The use of the term "lite residential equipment was discussed to be implemented into the village code. Public Comment: Resident expressed that we should consider adding any battery-operated equipment as well as that is a disturbance.

#### Mayor:

- Walkway #1: Removal of the stairs to install an ADA compliant ramp for handicap access or the quad to get on the beach in case of emergency. It needs to be close to the new Constabulary for easy access on and off the beach. Trustee Craig and the temporary Assistant Clerk have been working with the County to have this constructed. The County gave a list of items to compile, and the village is working to have it complete. This will be at the expense of the village. Resident informed the village that walkover #7 is falling apart. States there are boards coming up and the steps are falling apart. The village will contact SC Parks Dept regarding this issue.
- Rental Law: The Mayor is putting forth a possible revocation or revision of the rental law. He believes it is difficult to enforce and believes that the homeowners should be held as equally

- accountable for any issues that arise as the renters. The Village Attorney will make a proposal for a possible change to the law.
- Village movie night: 7/31/22 The village will be having its annual village movie night July 31<sup>st</sup>. The movie this year will be Sing 2. Doors open at 7:30 movie begins at 8:30. The Village will provide popcorn and candy but please be sure to bring your own drinks and blankets or chairs. Signs are ready and will be placed around the village.
- Blood Drive: 7/31/22 at 906 Dune Road.
- VID District: Permits are in place. The VID will need to bond the money through the village. We need to find out the amount.
- Plovers: There were two renests and the fencing was modified
- Tax Bill reminder: Taxes are now considered past due. Please contact the office for the current amount owed. One resident in litigation for past due amount. The Trustees want to give the village attorney the authority to put a tax foreclosure if not paid in thirty days.
