Treasurer's Report:

- Received \$66,500.00 in Chips fund for new Ford 250 vehicle. John the building inspector applied for the funds and we are glad to have the cost of the vehicle fully covered.
- Paid the annual pension invoice we had budgeted \$130,000, the estimate came in at \$120,000 and by paying it early we paid only \$118,000.
- Our building department has brought in \$59,900 and we had only budgeted \$30,000 for the year.

Trustee Report:

- Michael Craig spoke of a meeting he and the Mayor had with Fred Thiele regarding a transfer tax for the beach fund. Fred Thiele was supportive and said if we could get support from senator Palumbo, he would sponsor the bill. We would be able to enact a transfer tax for the sale of properties in our village. The money would go into a modest fund but stay in our village and eventually go to pay towards emergencies or a portion of the cost for the village. Renourishment projects are expensive and if you must collect money all at once, at the time of the occurrence, it can be painful. Establishing this fund ahead of time can help us be prepared.
- Trustee Michael Craig mentioned the constable contracts need to be renegotiated next year. Trustee Craig would like to get ahead of the negotiations to help the process run smoothly. He wants to do right by our constables and have an open dialog with the union to find out what they are thinking and looking for in the new contract.
