## **Opened Public Hearing**

Public Hearing on a Proposed Local Law of 2023, the Title of which is "Local Law No. of 2024, a Local Law Amending Chapter 560, Table 560B, Dimensional Regulations in the Residential Zone of the West Hampton Dunes Village Code to Change 2 Story Limit to 3 Story Limit."

Three definitions need to be changed in our code:

- 1. How a story is defined
- 2. A story above grade
- 3. Basement changed in State code

It is the internal structure of the house that would be changed from two stories to three stories. This does not change the outside dimensions of a house, the exterior will remain the same. It only effects the definition of stories within the envelope that already exists by our zoning.

The Public Hearing is open for discussion at this time and will continue to next month.

Mayor Vegliante reads and explains an overview of the 2024-2025 Tentative Budget.

Public comment was taken. Resident Sylvain Mirochnikoff from 692 Dune Road objected to the mayor's salary. Mirochnikoff believes his salary is not justified for the size of this Village compared to other Villages around. Joe Prokop explained that you cannot compare other Villages "apples to apples". The infrastructure in this Village is set up differently from other Villages that have a large support staff. Overall, our Village office operates on a small salary.

The total increase in budget had a slight increase of .0004% The budget is available online or in our office for viewing and comments.

## **Mayor Report:**

- Plover: Fencing went up for the plovers the first week of April. Residents have gotten consideration for access to the beach. If you have not gotten access to the beach, you can email or call the village office and we can forward the information to Fish & Wildlife for consideration of a pathway to the beach.
- Election: The upcoming election is Friday June 21, 2024. It is the third Friday in June, and it will be held at 914 Dune Road from 12 noon 9 pm. Positions open for re-election are:

Filing of petitions can begin six (6) weeks before the election. Can check the Board of Election website for any further information.

You can vote one of (3) three ways. You must be a registered voter in the Village of West Hampton Dunes

- 1. In-person
- 2. Early Mail-in Ballot
- 3. Absentee Ballot
- Tax Bills: Tax bills will be out at the beginning of May. Please notify the village office if you have a change in mailing address.
- Movie Night: Annual WHD movie night is scheduled for Saturday July 27, 2024 Movie TBD.
- NYCOM: The Mayor will be attending the annual NYCOM Executive Committee meeting May 15-17<sup>th</sup>.
- Road flooding West end of Village: The mayor is trying to work with the Commissioner of Suffolk County Department of Public Works, Charlie Bartha to help fund the road repair. Flooding is due to both rain and tide conditions. The road will need to be raised, which is quite costly. The village will need to get bids to acquire a new engineering report.
- Renourishment: Scheduled for the fall. We received the maps and were not satisfied with what it was showing. Unfortunately, the beach was surveyed before the recent storms, so it needs to be resurveyed. We have written the Army Corp a letter and have asked them to come back to reassess and resurvey the beach.
- Annexation: The Village is looking to fill in the entire unincorporated area, excluding the multiple dwelling places in between, roughly 50 houses. The purpose for these homes to join our incorporated village is

- so they can enjoy the same services that are provided to the village. The benefit to the Village is it will increase the assessment base which in turn will increase the tax base. Need to petition and get signatures.
- Summer Construction: The mayor would like to get a law put into effect constricting early morning construction hours. Other restrictions could apply to construction equipment and dumpster deliveries limiting the time of day they can be dropped off. Please email any ideas to the village office or call the office.
- Westhampton Ambulance: Westhampton Ambulance is looking to store ATV's and other equipment at 914 Dune Road.
- VID: Trustee Trimarchi spoke about the current VID project. They have done the first walk through took photos and walked the properties.
- DOS meeting in Albany: Mayor Vegliante, John McAlary the building inspector, Trustee Harvey Gessin and attorney Joe Prokop went to Albany to have a meeting with Secertary of State Rob Rodrigues and Mark Patterson. Constructive meeting discussing the villages three- and four-story issues along with the propane tank concerns. The Department of States attorneys are willing to work with Joe Prokop and David Yaffee to help resolve any ongoing issues.

## **Treasurer Report:**

- Statements and bank reconciliations were all emailed out prior to the meeting to the Board
- Treasurer Claire Vegliante announced that she intends to retire by the end of the year. She has built money into her budget to help train a new employee.

# **Trustees Report**:

- Trustee Craig discussed the need to find creative ways to raise money for the transfer tax fund. This is a legislative act that needs to be set up to institute a transfer tax to help fund beach renourishment. The fund is financed by the special assessment amount of \$300 on our tax bills every year.
- Trustee Trimarchi questioned the mayor's residency and claims he does not have a domicile in the Village. The mayor stated he has an active lease at 790A Dune Road and that is a viable document for proof of residency.
