Section 1.0 Title, Enactment, Effective Date,
Purpose, and Definitions.

1.1. Title

This Local Law shall be entitled “Local Law No.3 of 2010 of the Incorporated Village of West Hampton Dunes, a Local Law Adopting Regulations regarding Parking Regulations in the Village of West Hampton Dunes.”

1.2. Enactment.

Pursuant to Section 10 of the Home Rule Law and the Village Law of the State of New York the Incorporated Village of West Hampton Dunes, County of Suffolk and State of New York, hereby enacts by this Local Law of 2010, a Local Law of the Village of West Hampton Dunes.

1.3. Effective Date.

This local law shall take effect on the adoption of this local law by the Board of Trustees.

1.4 Findings.

The Board of Trustees of the Village of West Hampton Dunes determines and finds that it is in the best interests of the Village, its residents, property owners and guests, and of the preservation of good order and public safety in the Village of West Hampton Dunes to adopt regulations prohibiting parking in public places after dusk and prior to sunset and limiting parking to two hours in certain zones.

1.5. Purpose and Intent of Local Law.

The purpose and intent of this Local Law is to protect the safety and well-being of the

residents of the Village and their guests and families as well as the atmosphere and peace and tranquility of the Village by adopting regulations regarding parking in the Village of West Hampton Dunes.

2.0 General Provisions;

2.1 No Parking in Public Places from Dusk to Dawn

It shall be prohibited to park a motor vehicle of any kind in any public place in the Village of West Hampton Dunes from after dusk to prior dawn each day,

2.2 Parking Limited to two hours in certain zones and posted regulations

Parking for any vehicle shall be limited to two continuous hours in certain zones to be designated by the Board of Trustees and in accordance with posted regulations.

2.3 Violations, Fines and Penalties

Each violation of this local law shall be subject to a fine of not more than two hundred and fifty dollars (\$250), and each day that a violation shall exist shall be a separate violation of this local law.

3.0. Severability.

In the event that any section or portion of this Local Law shall be deemed to be unenforceable or of no effect, the remainder of the Local Law shall survive and remain in full force and effect.
