1 (The meeting was called to order at 7:35 p.m.)

2 MAYOR VEGLIANTE: Okay. I'm going to --

3 CLERK SADELI: It's 7:35.

4 MAYOR VEGLIANTE: I'm going to skip the
5 Pledge of Allegiance. We're going to start the
6 Budget Hearing first.

7 So I have very good news to report. The
8 Village Board, and Claire and Angela all worked
9 very hard, we put together a budget. While it
10 wasn't easy, and the costs every year go up, we
11 kept the entire cost under the 2% tax cap, one of
12 the few villages on the East End that have done
13 that. And the increase in the taxable rate is
14 very little, so you'll see a small increase in
15 your taxes, but far less than the 2% rate that we
16 were afforded. It took a lot of work, we got it
17 done, and it's going to be a good year.

18 What else? I need a motion to pass the
19 budget?

20 CLERK SADELI: No. Are we reviewing it
21 again or --

22 MAYOR VEGLIANTE: Do you want to review the
23 budget?

24 TRUSTEE GOLDFEDER: I don't need to. I
25 think you did an excellent job. Claire, thank

1 you very much, really well done.

2 MAYOR VEGLIANTE: Thank you, Barry.

3 TREASURER VEGLIANTE: Thank you, Barry.

4 MAYOR VEGLIANTE: Yeah, everybody worked
5 really hard. You know, we've had a couple of
6 problems this year that have been, unfortunately,
7 legal in nature. We've had a lot of outside
8 counsel, Joe has been coordinating that. And
9 even with all the outside counsel and the legal
10 difficulties, we've kept the budget very, very
11 modest.

12 You know, it's -- every year there are
13 increases in things like healthcare just
14 normally, and with a 2% cap, of course, we passed
15 the option to be -- to go over it. With a 2%
16 cap, we've -- we tried very hard to maintain it
17 under the 2%, and we did it, we got it done.

18 So very little of your tax will be impacted
19 this year. You'll see a slight increase. And,
20 hopefully, by next year, if we can successfully
21 get the annexed part of the Village and get more
22 homes in the Village, we may even do better.

23 Also, there has been some recent sales this
24 year that are very encouraging. There's one
25 house that sold for nearly \$6 million in our

1 Village, first one to approach that kind of
2 number. That was very exciting, and there's more
3 to follow. There's several homes being built and
4 being offered in very -- very near the \$6 million
5 range. All that helps to increase the base of
6 our taxable rate, and so we should root very hard
7 for these people to be successful in building
8 those beautiful homes.

9 As you may have heard -- well, we'll go on
10 to that later on. What do you want to with the
11 budget?

12 CLERK SADELI: Well, we have to do the
13 budget.

14 MAYOR VEGLIANTE: Right.

15 CLERK SADELI: Joe, do we have to --

16 ATTORNEY PROKOP: I would ask the public --
17 see if there's any public comment.

18 MAYOR VEGLIANTE: Does anyone want to
19 comment on the budget? You know, it's been most
20 posted on our website.

21 CLERK SADELI: Hold on, I'll unmute
22 everyone.

23 MAYOR VEGLIANTE: Everyone is unmuted, so
24 if you have anything to say, please ask, now is
25 the time. Where are you going, Ang?

1 (Laughter)

2 CLERK SADELI: Why did it get so small?
3 Hold on, we just got to get back to it.

4 MAYOR VEGLIANTE: Hold on, we're having
5 some technical difficulties.

6 CLERK SADELI: Oh, I'm viewing somebody
7 else's screen, that's why.

8 MS. BRAATEN: Angela, if I could ask, just
9 ask if people could, when they're speaking, just
10 identify themselves and spell their last names,
11 first and last names.

12 CLERK SADELI: Sure.

13 MS. BRAATEN: Thank you.

14 CLERK SADELI: Let me just --

15 MAYOR VEGLIANTE: There you are.

16 CLERK SADELI: There we go. Okay, we're
17 back on. So if anybody has a comment about the
18 budget.

19 (No Response)

20 MAYOR VEGLIANTE: Well, that sounds great.

21 (Laughter)

22 MS. MULDOON: Good job.

23 MAYOR VEGLIANTE: All right. All right.
24 Joe, what's next? What do we have to do, pass
25 the budget?

1 ATTORNEY PROKOP: There would be a motion
2 to close the public hearing, and then a motion to
3 approve the budget.

4 MAYOR VEGLIANTE: I'm asking for a motion
5 from my Board to close the Public Hearing.

6 TRUSTEE EFF: Motion.

7 TRUSTEE GOLDFEDER: I'll make a motion.

8 TRUSTEE CRAIG: (Raised hand)

9 MAYOR VEGLIANTE: You make the motion,
10 John?

11 TRUSTEE EFF: Yeah.

12 MAYOR VEGLIANTE: Okay. Seconded by?

13 CLERK SADELI: I saw Mike's hand go up.

14 MAYOR VEGLIANTE: Mike?

15 TRUSTEE CRAIG: Second.

16 MAYOR VEGLIANTE: Okay. All in favor?

17 TRUSTEE CRAIG: Aye.

18 TRUSTEE EFF: Aye.

19 TRUSTEE GOLDFEDER: Aye.

20 MAYOR VEGLIANTE: Any opposed?

21 (No Response)

22 MAYOR VEGLIANTE: None opposed, unanimous.

23 Motion to approve the budget, please.

24 TRUSTEE CRAIG: I'll make a motion, Gary.

25 MAYOR VEGLIANTE: Mike made the motion.

1 Barry, you second it?

2 TRUSTEE GOLDFEDER: Second.

3 MAYOR VEGLIANTE: All in favor?

4 TRUSTEE CRAIG: Aye.

5 TRUSTEE EFF: Aye.

6 TRUSTEE GOLDFEDER: Aye.

7 MAYOR VEGLIANTE: None opposed.

8 Okay. Let's go to our regular agenda.

9 CLERK SADELI: We've got to open up our
10 regular meeting, Joe?

11 MAYOR VEGLIANTE: Yeah.

12 ATTORNEY PROKOP: Yes.

13 MS. BRAATEN: Angela, do you want me to
14 continue, or do you want me to stop here?

15 ATTORNEY PROKOP: No, continue, please.

16 MS. BRAATEN: Okay.

17 MAYOR VEGLIANTE: Okay. We're going to
18 open the -- open the meeting. I guess, first,
19 I'll talk about --

20 UNKNOWN SPEAKER: It just goes up, what is
21 it, one point difference?

22 UNKNOWN SPEAKER: Yes.

23 MAYOR VEGLIANTE: I'm sorry?

24 MS. BRAATEN: Who is speaking?

25 CLERK SADELI: Hold on one second. Let me

1 just mute everybody, and when we get, I'll unmute
2 it. Hold on, I've got to find all the Trustees
3 now.

4 MAYOR VEGLIANTE: That's not a beer, it's
5 iced tea, if anybody wants to know.

6 (Laughter)

7 MAYOR VEGLIANTE: I wish it was a beer.

8 CLERK SADELI: Okay. I think all the
9 Trustees -- Lucia, you're still muted. I've got
10 to find you, hold on. Lucia. Okay. I think
11 that's all of us.

12 MAYOR VEGLIANTE: Okay. Guys, first and
13 foremost, the beach renourishment is complete and
14 it held up very well, even though today we had
15 severe winds. We had some winds that approached
16 65 miles an hour, some wind gusts. They were --
17 there were awesome and huge waves, 12-footers
18 coming on shore. Our beach held up very well,
19 although some roofs and some of the -- some
20 paneling, some outside sheathing and -- had blown
21 off. So there will be some repairs being made
22 during the week, and these are -- any emergency
23 repairs are permitted under the -- under the --
24 under the new ruling of the Governor. So roof
25 repairs, you can have a crew on the roof working,

1 and other essential services. And if your
2 engineer or architect dictates to us a letter
3 that indicates the work being done is essential
4 to the safety of the home or the community,
5 you're entitled to keep your crew working. We do
6 ask that you keep socially distant and that you
7 provide your workers, all the workers, with face
8 masks and protective gear.

9 Anyone who's concerned about anything going
10 on, don't hesitate to call the Constables or my
11 office any time and we'll investigate it.
12 That's -- that's the news on the beach and the --
13 what's going on.

14 As some of you have heard, we do have one,
15 one confirmed case of the COVID virus in the
16 Village, but it's not -- there's no serious --
17 they're still in their home, they're not
18 hospitalized, and things are doing well. The
19 Constables are on patrol all the time. We do ask
20 that everybody remain socially distant. And
21 that's about it for that.

22 Next on the agenda is we're replacing one
23 vehicle in our Police fleet. The Expedition, the
24 large Expedition is going to be traded in, and
25 we're getting a new Explorer for the patrol.

1 That will be in probably by early summer, and our
2 entire fleet will be very much up to date. I
3 think the -- at that point, the highest mileage
4 vehicle will be at 60,000 miles. So we'll be in
5 good shape with that vehicle.

6 I need an order to extend the Executive
7 Order in the Village. I need a motion, right?

8 CLERK SADELI: Right, Joe?

9 MAYOR VEGLIANTE: Joe, we need a motion?

10 ATTORNEY PROKOP: Yes.

11 MAYOR VEGLIANTE: We're going to --

12 ATTORNEY PROKOP: We're going to extend it
13 for another 30 days.

14 MAYOR VEGLIANTE: Okay. Do I have a
15 motion?

16 TRUSTEE CRAIG: Sure, I'll make a motion,
17 Gary.

18 CLERK SADELI: Mike. Seconded by anybody,
19 Barry, John?

20 TRUSTEE EFF: I'll second it.

21 MAYOR VEGLIANTE: John.

22 TRUSTEE EFF: I'll second.

23 MAYOR VEGLIANTE: All in favor?

24 TRUSTEE CRAIG: Aye.

25 TRUSTEE EFF: Aye.

1 TRUSTEE GOLDFEDER: Aye.

2 MAYOR VEGLIANTE: None opposed.

3 Okay. Some of you may have seen the plover
4 fencing. In all this crisis that's going on and
5 social distancing, the bird people still came out
6 in time to protect the birds and put up the
7 protective fencing. If you have a special need
8 or a doctor's note that can indicate that the
9 fencing is stopping you from getting to the
10 beach, please let us know as quickly as possible.
11 We've accommodated many families that had
12 doctors's letters and we were helping -- we're
13 willing to help, but, you know, it's not
14 something we have absolute control over. We can
15 only appeal to them and see if they'll modify it.

16 But right now the fencing looks minor
17 compared to years before, so I think we're okay.
18 And I haven't heard anyone else complain, so I
19 think we're all right for now. But I just want
20 you to know, you can always call us and let us
21 know.

22 Do you want to do a Trustees Report,
23 Claire?

24 TREASURER VEGLIANTE: Treasurer?

25 MAYOR VEGLIANTE: A Treasurer's Report, I'm

1 sorry.

2 TREASURER VEGLIANTE: Well, we've just
3 been working very hard on the budget, and other
4 than that, we're really on track for what's
5 happening at the moment.

6 MAYOR VEGLIANTE: Claire, we're --

7 TREASURER VEGLIANTE: Other than that,
8 yeah.

9 MAYOR VEGLIANTE: Our budget --

10 TREASURER VEGLIANTE: I think everything's
11 in order, the budget is --

12 MAYOR VEGLIANTE: Our budget is in great
13 shape.

14 TREASURER VEGLIANTE: Yeah.

15 MAYOR VEGLIANTE: We don't have any
16 problems. We were right on target with all our
17 predictions, so I think next year's budget will
18 be equally good, right?

19 TREASURER VEGLIANTE: Yeah, I think we
20 should be in great shape.

21 MAYOR VEGLIANTE: Yep. Okay.

22 CLERK SADELI: You just need a motion for
23 the bills.

24 MAYOR VEGLIANTE: I need a motion to --
25 motion approving the audited and bills and

1 vouchers for the Village of West Hampton Dunes.

2 Motion? Come on, guys. Barry?

3 TRUSTEE EFF: I'll make that motion.

4 TRUSTEE GOLDFEDER: Motion. Yeah, motion,
5 the second.

6 MAYOR VEGLIANTE: Second, okay. All in
7 favor?

8 TRUSTEE CRAIG: Aye.

9 TRUSTEE EFF: Aye.

10 TRUSTEE GOLDFEDER: Aye.

11 MAYOR VEGLIANTE: None opposed.

12 Okay. I need a motion to adopt the
13 resolution waiving the reading of the minutes.
14 John?

15 TRUSTEE CRAIG: I'll make that, Gary.

16 MAYOR VEGLIANTE: Okay, Mike. John, you
17 second it?

18 TRUSTEE EFF: Yep.

19 MAYOR VEGLIANTE: All in favor?

20 TRUSTEE CRAIG: Aye.

21 TRUSTEE EFF: Aye.

22 TRUSTEE GOLDFEDER: Aye.

23 MAYOR VEGLIANTE: None opposed.

24 Motion to adopt the resolution for the bond
25 for the new vehicle.

1 TRUSTEE CRAIG: I make that motion, Gary.

2 MAYOR VEGLIANTE: Thank you, Mike.

3 Seconded?

4 TRUSTEE EFF: Second.

5 MAYOR VEGLIANTE: John, is that you? Okay.

6 All in favor?

7 TRUSTEE CRAIG: Aye.

8 TRUSTEE EFF: Aye.

9 TRUSTEE GOLDFEDER: Aye.

10 MAYOR VEGLIANTE: None, none opposed. Okay.

11 Trustees Report. Trustees, you have

12 anything you want to add to the meeting? You

13 guys are on deck. Brian, Timmy, you're on also?

14 SERGEANT HENNIG: I'm on, Gary. I believe

15 Tim is as well.

16 MAYOR VEGLIANTE: Okay.

17 SERGEANT TURNER: I'm here.

18 MAYOR VEGLIANTE: Hold on. Do the Trustees

19 have anything they want to add?

20 TRUSTEE CRAIG: Gary, I don't have

21 anything. If anything, I would give my time to

22 Joe to review anything that he feels we should be

23 going over at this time.

24 MAYOR VEGLIANTE: Okay. Joe, I think we're

25 preparing the bid on 656. When do you think we

1 should release the bid? I think it should be
2 next week or the week after?

3 ATTORNEY PROKOP: I think next week, yes.

4 MAYOR VEGLIANTE: Okay. All right. All
5 right. Joe, what do you have to add? We have
6 the Attorney's Report.

7 ATTORNEY PROKOP: Just that we've made a
8 lot of progress regarding the fuel thanks.

9 MAYOR VEGLIANTE: Oh, yeah.

10 ATTORNEY PROKOP: We got a very favorable
11 ruling from New York State, and, Gary, maybe you
12 want to talk about that.

13 MS. BRAATEN: Angela, I'm sorry. Can you
14 hold on one second? Hold on.

15 CLERK SADELI: Hold on one second, Joe.

16 MS. BRAATEN: Joe, I'm getting two voices,
17 because your phone is on and I think you're on
18 video, so --

19 ATTORNEY PROKOP: Okay, I'll try it. How's
20 this?

21 CLERK SADELI: Yeah, that's it.

22 MAYOR VEGLIANTE: That's fine.

23 MS. BRAATEN: Thanks.

24 MAYOR VEGLIANTE: Better.

25 ATTORNEY PROKOP: So we have -- we got a

1 very favorable ruling from New York State
2 regarding the fuel tanks, and we -- many of the
3 properties that were previously nonconforming, it
4 looks like now we're conforming, as far as New
5 York State is concerned.

6 MAYOR VEGLIANTE: Basically, Joe --

7 ATTORNEY PROKOP: To let the owners know.

8 MAYOR VEGLIANTE: Basically, what they did
9 was they were very reluctant and tried not to,
10 but they had to admit at the end exactly what we
11 had said at the beginning, that we were right
12 when Herb made the determination that if it's
13 10 feet from the home it services, it doesn't
14 have to be more than 10 feet from the house next
15 door. And they finally admitted that and I think
16 they've -- that ruling will help us very much.

17 MR. LICHTER: How will we know who that
18 applies to?

19 MAYOR VEGLIANTE: Well, if, in fact, you
20 have a 10-foot distance from your home to your
21 tank, and you're not closer to the house next
22 door, none of them can be, then you'll be fine.
23 But if, in fact, you're closer than 10 feet to
24 your home, your own home, that may still have to
25 be meted out.

1 CLERK SADELI: And just if anybody wants to
2 speak, it's fine. Just announce yourself, so
3 that the Court Reporter can -- can know who's
4 speaking.

5 MR. LICHTER: Yeah, sorry. This is
6 Brian Lichter at 729 Dune Road.

7 MAYOR VEGLIANTE: All right.

8 MR. LICHTER: I have one more question on
9 that. I'm not sure we are, I can measure. I'm
10 not sure we're within 10 feet. But if we're not
11 and we wanted to lift it from where it is and
12 then put it back underground 10 feet away, can we
13 do that, or once we pull it out, do we have to
14 keep above?

15 MAYOR VEGLIANTE: No, no, no, that's fine.
16 If you have -- first of all, it should be
17 surveyed, Brian, to be certain. Even if it looks
18 like it's less than 10 feet, the survey may
19 indicate that it is, it's good enough.

20 Also, there's the issue of, you know, our
21 homes are elevated, so there's no real danger on
22 any of these homes.

23 MR. LICHTER: Yeah, of course.

24 MAYOR VEGLIANTE: So, if you have a problem
25 and you believe that -- have you been cited by --

1 MR. LICHTER: We've been cited, yes.

2 MAYOR VEGLIANTE: Okay.

3 MR. LICHTER: We have, and we've had --
4 we've had Liberty Gas out to kind of figure out
5 where we may want to move it to.

6 MAYOR VEGLIANTE: Right.

7 MR. LICHTER: We'd prefer, obviously, not
8 to do that, but we want to be compliant, so.

9 MAYOR VEGLIANTE: Well, you can always
10 apply for a variance. And the last -- one of our
11 residents had applied for a variance and we
12 actually helped him. Our lawyers went into the
13 courtroom with him with our engineers and he won,
14 he won his variance. So if you want to apply for
15 a variance, I suggest you do that.

16 MR. LICHTER: Okay. Maybe I'll -- instead
17 of, you know, wasting everybody's time here,
18 maybe I'll call you guys tomorrow.

19 MAYOR VEGLIANTE: Fine, yeah.

20 MR. LICHTER: I've actually had the
21 Building Inspector out here and we're trying to
22 figure something out, so.

23 MAYOR VEGLIANTE: Okay.

24 MR. LICHTER: Okay. This is helpful.

25 Thank you.

1 MAYOR VEGLIANTE: Very good.

2 CLERK SADELI: You want me to unmute
3 everybody?

4 MAYOR VEGLIANTE: Okay. You know what,
5 we'll let the Constable's Report, because there's
6 some unfortunate things that have occurred during
7 this time. Brian, are you on?

8 SERGEANT HENNIG: Yes, Gary. Yeah,
9 unfortunately, we were not the only victims of
10 it. It happened in a few other areas --

11 MAYOR VEGLIANTE: Oh, I know.

12 SERGEANT HENNIG: -- on the East End.
13 They're targeting Range Rovers. We're asking all
14 the residents to please double-check at night,
15 lock your cars. Don't leave a key fob in the
16 vehicle. Apparently --

17 MAYOR VEGLIANTE: Do not leave your keys in
18 the vehicle. Every one that's stolen, they're
19 driving away as if they own it. Get in --

20 SERGEANT HENNIG: Yeah.

21 MAYOR VEGLIANTE: -- hit the button, and
22 off they go. So --

23 SERGEANT HENNIG: They're targeting
24 Range Rovers specifically, which I don't -- I
25 don't want to publicly disclose why they're --

1 they're doing it, but it's a -- it's an
2 organized -- it's an organized group that's doing
3 it. And it's --

4 MAYOR VEGLIANTE: There's a big market in
5 South America.

6 SERGEANT HENNIG: Right. And unfortunately
7 for us, it -- you know, there's been a lot of
8 vehicles coming and going all hours of the day
9 and night, you know, with everybody coming out a
10 little earlier than expected. So, you know, it
11 wasn't -- the vehicle wasn't -- you know, we
12 watched -- the Officer on the midnight actually
13 watched the vehicle leave, but it didn't have a
14 broken window, it wasn't speeding. He just
15 assumed it was a resident, you know, going to get
16 something from town, from 7-Eleven, or whatever,
17 and it was just an unfortunate occurrence. But,
18 yes, please make sure you do not leave your key
19 fobs in your vehicles.

20 CLERK SADELI: Brian, do you want to put
21 together an email that I can send out to the
22 residents?

23 SERGEANT HENNIG: Yes, we could do that.

24 MAYOR VEGLIANTE: Yeah, we'll do that.

25 CLERK SADELI: Okay.

1 SERGEANT HENNIG: And then, Gary, if you
2 want to touch on that -- you were asking about
3 the cost of that pole camera. Do you want to do
4 that separately, or do you want to discuss that?

5 MAYOR VEGLIANTE: We could discuss it,
6 Brian.

7 SERGEANT HENNIG: It was -- I got back the
8 numbers today, so it's around 27,000, \$28,000,
9 which is -- actually, that's from a company
10 that's under the State bid. That's -- they're
11 actually less than the State bid price.

12 MAYOR VEGLIANTE: Very good. Well, you
13 know, I think that when we -- when we build --
14 when we get the contracts for the house, when we
15 get the bids in for the house, when we bond the
16 house, I think we'll incorporate that into the
17 bond, so it will be easily accommodated by the
18 bond at the --

19 TRUSTEE EFF: Gary, I missed that. What
20 was that? Was that for the speed reader?

21 MAYOR VEGLIANTE: That's for the plate
22 reader, John.

23 TRUSTEE EFF: Oh, the plate reader, all
24 right.

25 MAYOR VEGLIANTE: Yep, yep.

1 TRUSTEE EFF: All right. That -- and for
2 obvious reasons, based on what we just heard, we
3 need that more now than ever.

4 MAYOR VEGLIANTE: Well, yeah, it's
5 important. It will be a great tool for us,
6 because it will actually indicate when the
7 vehicles, when all the vehicles come and go in
8 through the Village, and if any of them have an
9 outstanding violation, we'll be able to spot them
10 right away.

11 SERGEANT HENNIG: Yeah, the system, Gary --

12 TRUSTEE EFF: Brian, how --

13 SERGEANT HENNIG: Oh, go ahead. I'm sorry,
14 John.

15 TRUSTEE EFF: Brian, how are we making out
16 with getting the speed monitoring device
17 that's --

18 MAYOR VEGLIANTE: The radar?

19 TRUSTEE EFF: Yeah.

20 MAYOR VEGLIANTE: The radar?

21 SERGEANT HENNIG: Are you referring to like
22 a radar sign that just displays the speed of the
23 vehicle?

24 MAYOR VEGLIANTE: Right.

25 TRUSTEE EFF: Yeah. Well, it's replacing

1 what's not working now on the highway, correct?

2 MAYOR VEGLIANTE: Right.

3 SERGEANT HENNIG: You're talking about -- I
4 just want to make sure we're talking about the
5 same device. So it's just basically the sign
6 that says what the speed limit is and it says
7 what your -- your speed is?

8 MAYOR VEGLIANTE: Right

9 SERGEANT HENNIG: What you're traveling at,
10 correct?

11 TRUSTEE EFF: Yeah. I mean, it's replacing
12 what's there --

13 SERGEANT HENNIG: Yes.

14 TRUSTEE EFF: -- that's not working.

15 SERGEANT HENNIG: Right, that would be --
16 we had prices between 2 and \$5,000 for that,
17 depending on the model that we choose.

18 TRUSTEE EFF: Okay. How long does it
19 take --

20 SERGEANT HENNIG: We just have to discuss
21 it, but that --

22 TRUSTEE EFF: How long does it take to get
23 something?

24 SERGEANT HENNIG: That's very easy to get
25 that installed.

1 MAYOR VEGLIANTE: We could do that right
2 away.

3 SERGEANT HENNIG: We could get that
4 relatively quick.

5 TRUSTEE EFF: Okay.

6 MAYOR VEGLIANTE: I think at the end of
7 this, at this -- at the end of this fiscal year,
8 if we have any money aside, I think we may have a
9 little extra money, maybe I'll get it before the
10 summer, John.

11 TRUSTEE EFF: I think it's a good idea.

12 MAYOR VEGLIANTE: Yeah, yeah.

13 SERGEANT HENNIG: We were holding -- we
14 were holding out initially to get one when the
15 new building was built, so it would be powered by
16 that instead of -- the problem with the old one
17 was it was battery operated and we were
18 constantly changing the batteries out, and the
19 batteries have a short life. So it would be much
20 or effective to have one that's actually, you
21 know, wired into the new building.

22 The camera system that Gary was referring
23 to before this, that one would run independent of
24 the building, they can install that any time.

25 TRUSTEE EFF: Right. And, Gary, let me ask

1 you a question.

2 MAYOR VEGLIANTE: Sure.

3 TRUSTEE EFF: Have we -- have we gotten any
4 kind of a proposal on -- for signs, meaning for
5 bulletin signs that we can put notices up?

6 MAYOR VEGLIANTE: Yeah, the enclosed, the
7 enclosed sign?

8 TRUSTEE EFF: Right.

9 MAYOR VEGLIANTE: Yeah. Angela and I, we
10 located a couple of companies in Pennsylvania and
11 all over. They're about 800 bucks, and I think
12 we're going to buy two of them.

13 TRUSTEE EFF: Yeah, I was going to say
14 that's nothing.

15 MAYOR VEGLIANTE: No.

16 TRUSTEE EFF: I mean, it's good, we need
17 that.

18 MAYOR VEGLIANTE: About eight hundred?

19 CLERK SADELI: The most I saw was \$800.

20 MAYOR VEGLIANTE: Yeah, about 800 was the
21 biggest one. I think we're going to get two of
22 them.

23 TRUSTEE EFF: Yeah.

24 MAYOR VEGLIANTE: One for the Constabulary,
25 one for the beginning of the Village.

1 TRUSTEE EFF: Right.

2 MAYOR VEGLIANTE: I know Mike has been very
3 discouraged. Now we're not going to have you
4 rebuild it every year. But these are fiberglass
5 signs, they're fairly weatherproofed.

6 TRUSTEE CRAIG: I'm good with that, Gary.

7 (Laughter)

8 MAYOR VEGLIANTE: Well, I'll let you
9 install them, Mike.

10 TRUSTEE EFF: Yeah.

11 TRUSTEE CRAIG: It's 20 years old. All
12 right. We'll have an installation party with the
13 about BBPA.

14 TRUSTEE EFF: Well, why don't we -- why
15 don't we put a plaque underneath the new sign,
16 and say, "Dedicated to Mike Craig for His
17 Efforts".

18 TRUSTEE CRAIG: No, that's okay.

19 (Laughter)

20 MAYOR VEGLIANTE: I'll see if I can order
21 it with the plaque, John.

22 TRUSTEE CRAIG: I'm happy to do it.

23 (Laughter)

24 MAYOR VEGLIANTE: Yeah. So we'll get those
25 done this year --

1 TRUSTEE EFF: Okay.

2 MAYOR VEGLIANTE: -- before the summer.

3 SERGEANT HENNIG: Gary --

4 ATTORNEY PROKOP: Probably --

5 SERGEANT HENNIG: -- the one last thing
6 that we would like -- oh, sorry.

7 ATTORNEY PROKOP: I'm sorry, excuse me. Go
8 ahead.

9 SERGEANT HENNIG: No, no. Just a -- this
10 is Brian. Just one last thing I want to add is
11 that the -- we're very proud and happy with our
12 residents that came out from the City.

13 MAYOR VEGLIANTE: Yeah.

14 SERGEANT HENNIG: The vast majority of them
15 did the right thing. They quarantined themselves
16 for two weeks before you saw them venturing out
17 for provisions, and everyone's been social
18 distancing. The few people that we are observing
19 that aren't are people from outside the
20 community, and we're working with Southampton
21 Town at Pike's and with Suffolk County at
22 Cupsogue to make sure that those people are doing
23 that.

24 Gary's done a great job of working with the
25 County Executive to get the Park Rangers over at

1 Cupsogue, so they'll be assigned there on a
2 regular basis, which should alleviate quite a lot
3 of -- quite a few of the problems that we were
4 having, so.

5 MAYOR VEGLIANTE: You know, every day we
6 have a call at 4 o'clock with the County and we
7 get updated on what's going on. And brought it
8 up repeatedly that Cupsogue Park has constantly
9 been a problem for us, because it's a County park
10 and we don't have legal jurisdiction and
11 boundaries. So we're working on a mutual
12 agreement between the County and us to allow us
13 to help them help patrol it. But we also are
14 imploring the County to get some Rangers down
15 there, and they always promise they're going to
16 do what they can, but you know what that's like.
17 So I do, I do believe we will be getting some
18 more help on that, Brian.

19 SERGEANT HENNIG: Yes. Gary, for the last
20 two days we've had a Ranger there the entire day,
21 actually --

22 MAYOR VEGLIANTE: Oh, that's great.

23 SERGEANT HENNIG: -- even today with the
24 storm. They -- he looked like he was having a
25 lot of fun, but he was --

1 (Laughter)

2 SERGEANT HENNIG: He was the only one at
3 Cupsogue today, but he was there.

4 MAYOR VEGLIANTE: Oh, yeah, I don't think
5 there was many people tonight, unless they want
6 to get blown away.

7 SERGEANT HENNIG: So, Gary, unless there's
8 any questions for us, we'll turn it back to you.

9 MAYOR VEGLIANTE: Anybody got anything for
10 these guys?

11 CLERK SADELI: I'll unmute everyone. Okay.
12 Everyone's unmuted, if you have any questions.

13 MAYOR VEGLIANTE: Anybody have a question
14 for the Constables?

15 TRUSTEE GOLDFEDER: Nope, other than thank
16 you for everything that you do.

17 TREASURER VEGLIANTE: Yes.

18 MAYOR VEGLIANTE: They're working hard.

19 SERGEANT HENNIG: Thank you very much.

20 TRUSTEE EFF: Thank you.

21 MAYOR VEGLIANTE: Thank you. Hey, Bob, I
22 see you're on. Bob Mayer, I see you're on. You
23 had a question. They're going to reinstall --
24 they're going to reinstall the parallel parking.
25 It will not just be -- it will be angled parking.

1 They're going to take out the parallel parking
2 and put the angled back in before -- they say
3 before the summer.

4 MR. MAYER: Okay, great. We'd have enough
5 problem with the angled parkings.

6 MAYOR VEGLIANTE: I know.

7 MR. MAYER: Take it the way it is and
8 people would really going into town --

9 MAYOR VEGLIANTE: It would be a nightmare.
10 No, no.

11 MR. MAYER: It will be a disaster.

12 MAYOR VEGLIANTE: They're aware of that.
13 Now, John --

14 MR. MAYER: I do think that, I do think
15 that as I -- the enhanced --

16 (Background Noise)

17 MS. BRAATEN: I'm sorry, I can't -- I'm
18 sorry, repeat that, I can't hear.

19 MR. MAYER: Upgrade the value of our house.

20 MAYOR VEGLIANTE: I think you're right.

21 MS. BRAATEN: Hold on a second. Hold, hold
22 on one second. Somebody else's phone, they're
23 interfering, I couldn't hear what he said. There
24 were two people --

25 MAYOR VEGLIANTE: Bob Mayer was speaking.

1 MS. BRAATEN: Yeah. There was somebody
2 else on that I couldn't understand what he just
3 said.

4 CLERK SADELI: Hold on, everyone.

5 MR. MAYER: Okay.

6 MS. BRAATEN: Sorry.

7 MAYOR VEGLIANTE: You're back on.

8 CLERK SADELI: All right.

9 MAYOR VEGLIANTE: Go ahead, Bob.

10 MR. MAYER: Angela. Angela, are you
11 available during the week? I do Zoom calls about
12 three or four times a day.

13 (Laughter)

14 MR. MAYER: And the muting, the muting,
15 you can't get everybody --

16 CLERK SADELI: This is my second one, okay?
17 Don't judge.

18 MR. MAYER: We can't -- no, we can't get
19 everybody to mute themselves, they all want to be
20 heard.

21 CLERK SADELI: Well, I unmuted everybody,
22 not realizing everyone was probably having
23 conversations in the background.

24 MR. MAYER: That's fine.

25 MAYOR VEGLIANTE: You give Zoom seminars.

1 MR. MAYER: The conversation was basically
2 about the parking in the Town of Westhampton.

3 MR. MAYER: In the Village of Westhampton
4 Beach.

5 CLERK SADELI: Right.

6 MR. MAYER: Right, in the Village, because
7 right now it's not angled parking, head in, it's
8 actually parallel. And even with the few people
9 that are there, it's not a great parking
10 situation. But I had asked Gary what was going
11 to happen. If they redo the striping and stuff
12 for the summer --

13 MAYOR VEGLIANTE: Right.

14 MR. MAYER: -- it would be great.

15 MAYOR VEGLIANTE: That was until they
16 closed the sidewalks.

17 MR. MAYER: And I said that I thought that
18 the work that they did actually will improve the
19 value of all of our homes.

20 MAYOR VEGLIANTE: Yep, yep, that -- they
21 did that just so that they could get the sidewalk
22 work done, and they promised to have that done
23 before Memorial Day.

24 MR. MAYER: Yeah.

25 MAYOR VEGLIANTE: So I think it's going to

1 be fine, yep.

2 MR. MAYER: Okay, great. Thanks for the
3 answer.

4 MAYOR VEGLIANTE: Any time. You know, I'm
5 in the office. One of us are here every day,
6 we're usually around. I'll always return a call,
7 so anybody has any questions or needs, call me
8 immediately.

9 CLERK SADELI: You can -- and you can
10 email me.

11 MAYOR VEGLIANTE: Or email.

12 CLERK SADELI: I'm available every day by
13 email.

14 TRUSTEE GOLDFEDER: And, Angela, Gary, I
15 just have one question. If you can, Gary, just
16 move a little to the left.

17 MAYOR VEGLIANTE: My left or your left?

18 TRUSTEE GOLDFEDER: Did we --

19 CLERK SADELI: Oh, cut it out.

20 MR. GOLDFEDER: Did we put money in next
21 year's budget for a new chair for you.

22 (Laughter)

23 TREASURER VEGLIANTE: There's no money in
24 this year's budget.

25 CLERK SADELI: No.

1 MAYOR VEGLIANTE: No money in this year's
2 budget.

3 CLERK SADELI: No.

4 TRUSTEE GOLDFEDER: Also, Angela --

5 CLERK SADELI: The Mayor works with what
6 he has.

7 MAYOR VEGLIANTE: I work with what we got.

8 TRUSTEE GOLDFEDER: Angela, I don't think
9 you're six feet apart from Gary.

10 MAYOR VEGLIANTE: No, no, we're doing
11 pretty good.

12 (Laughter)

13 MAYOR VEGLIANTE: Oh, here comes Max.

14 CLERK SADELI: And Max is not six feet
15 either.

16 MAYOR VEGLIANTE: Max and I don't practice
17 social distancing.

18 CLERK SADELI: He doesn't know how to. If
19 anybody -- if there's no other questions,
20 we'll --

21 MAYOR VEGLIANTE: Now is your chance.

22 MS. FINE: One quick question. Quick
23 question, because you were talking about the --

24 MS. BRAATEN: Who is this? I'm sorry.

25 CLERK SADELI: Ilene Fine.

1 MS. FINE: I'm sorry. Yep, Ilene Fine. So
2 you were talking about the parking spots in town.
3 So they took all the little temporary spots in
4 front of the Chase to use the ATM. Are they
5 putting that back?

6 MAYOR VEGLIANTE: Oh, I don't know.

7 TREASURER VEGLIANTE: We don't know. They
8 reconfigured --

9 MAYOR VEGLIANTE: They reconfigured those
10 circles. I don't know --

11 TREASURER VEGLIANTE: Yeah, so that might
12 not be.

13 MAYOR VEGLIANTE: -- if they will have
14 parking. I'll find out.

15 MS. FINE: I mean, it is what it is, but,
16 you know --

17 MAYOR VEGLIANTE: Yeah.

18 MS. FINE: -- I'll stop by there to use the
19 ATM and now you can't park there.

20 MAYOR VEGLIANTE: Yeah. I'm thinking
21 that -- I don't know. That -- they only had
22 parallel parking there, they didn't have angled
23 parking on that side of the street. I'll see
24 what I could find out.

25 CLERK SADELI: I heard that the plans for

1 the parking are online. So if anybody is
2 interested in viewing them --

3 MAYOR VEGLIANTE: There you go.

4 CLERK SADELI: -- you can go on the
5 Westhampton Beach website and check that out.

6 MS. FINE: Okay. Thank you. I'm going on
7 mute.

8 ATTORNEY PROKOP: Gary, I have one thing to
9 go over, if you could, one other thing.

10 MAYOR VEGLIANTE: Go right ahead.

11 ATTORNEY PROKOP: Okay. So with regard to
12 the bond resolution, we need to adopt a SEQRA
13 resolution. So the motion would be to determine
14 that the adoption of the bond resolution is an
15 Unlisted Action, and that the -- excuse me, that
16 the Board is adopting Lead Agency status, that
17 the adoption of the bond resolution is an
18 Unlisted Action that will not have a significant
19 negative impact on the environment.

20 MAYOR VEGLIANTE: Motion made by who?

21 TRUSTEE CRAIG: I'll make it, Gary

22 MAYOR VEGLIANTE: Mike. Seconded?

23 TRUSTEE GOLDFEDER: Second, Barry.

24 MAYOR VEGLIANTE: Okay. All in favor?

25 TRUSTEE CRAIG: Aye.

1 TRUSTEE EFF: Aye.

2 TRUSTEE GOLDFEDER: Aye.

3 MAYOR VEGLIANTE: None opposed.

4 Anything else, Joe?

5 ATTORNEY PROKOP: Yeah. Did you mention
6 the renourishment on the Bayside?

7 MAYOR VEGLIANTE: The VID District?

8 ATTORNEY PROKOP: Yes.

9 MAYOR VEGLIANTE: No.

10 TRUSTEE CRAIG: No.

11 ATTORNEY PROKOP: Okay.

12 MAYOR VEGLIANTE: What do you want me
13 to say.

14 ATTORNEY PROKOP: No, just that it -- just
15 that it happened, that's all.

16 MAYOR VEGLIANTE: Yeah, they
17 reconfigured -- they -- they replaced some of the
18 stone that washed out and recovered it with sand.
19 It's getting beat up today and over the last
20 week, but it's still functioning exactly the way
21 it was designed. And I know some people are a
22 little concerned by it, but it's working very
23 well.

24 ATTORNEY PROKOP: And I have one thing for
25 Executive Session. I circulated a conference

1 number, if we could please, when we get done with
2 the public meeting, exit the meeting and then
3 call back on the conference number.

4 MAYOR VEGLIANTE: Okay.

5 ATTORNEY PROKOP: If that's possible. I
6 emailed it around an hour ago.

7 MAYOR VEGLIANTE: Do you have the
8 conference number, guys?

9 TRUSTEE GOLDFEDER: Yes, I have it.

10 TRUSTEE EFF: I don't, I don't have it.

11 ATTORNEY PROKOP: If you look on your
12 email, it will be on your email.

13 TRUSTEE EFF: All right.

14 MAYOR VEGLIANTE: I think you were all
15 forwarded it.

16 TRUSTEE CRAIG: Yeah, I got it.

17 TRUSTEE EFF: All right.

18 MAYOR VEGLIANTE: So do we have anything
19 else anybody want to talk about?

20 MR. WANG: I have a question. This is
21 Ed Wang.

22 MAYOR VEGLIANTE: Hi, Ed, how are you?

23 MR. WANG: I'm good. How are you, Gary?

24 MAYOR VEGLIANTE: Very good.

25 MR. WANG: Is there any new developments on

1 the easement situation?

2 MAYOR VEGLIANTE: Yeah. I got a letter.
3 Joe, did you get -- I don't know if I sent it to
4 you. I got a letter from Greg Rinn today
5 describing some of the easements that currently
6 exist. Did you see that, Joe?

7 ATTORNEY PROKOP: No.

8 MAYOR VEGLIANTE: I'll get it over to you,
9 if I hadn't, hadn't gotten it to you yet.
10 Basically, he had -- I don't know. Joe, what do
11 you have to say about it? Joe?

12 ATTORNEY PROKOP: With regard to the -- we
13 want to move ahead with the -- an easement, the
14 easement that was proposed by Mr. Rinn. It may
15 not be in the location that Mr. Rinn wanted. And
16 we've been going over tax maps and the deeds that
17 we have to try to locate a place that would be
18 optimal for the Village and Mr. Rinn, so we could
19 accomplish -- finish the transaction. That's
20 basically where we're at. We don't -- we --

21 MAYOR VEGLIANTE: You know, the problem we
22 have, Joe, the title company in the County is not
23 functioning now.

24 ATTORNEY PROKOP: Yes. I mean, there's
25 really nobody to talk to on the other side right

1 now.

2 MAYOR VEGLIANTE: Right, there's nobody in
3 the County office.

4 ATTORNEY PROKOP: But when we -- when we
5 last viewed this before everything shut down, we
6 were looking at one other location that was
7 nearby that we believe would be more favorable
8 for the location of the easement. And we needed
9 to get information that we now are unable to get,
10 but I would believe that we'd be able to get that
11 in two or three weeks.

12 MAYOR VEGLIANTE: Yeah, I think you're
13 right.

14 MR. WANG: Follow-up question, please.

15 TRUSTEE CRAIG: Sure, yes, go head.

16 MR. WANG: Yeah, this is Ed Wang. Ed Wang
17 has a follow-up question. Are we -- are we
18 certain, like is it in writing that if you do get
19 this Bayside thing approved and then Gary -- not
20 Gary, Greg, Mr. Rinn, then, you know, allowed the
21 easement next to his property, are we -- like is
22 it in writing that the County then will go ahead
23 and rectify the problem over by my house? Is
24 that in writing that all this work will
25 actually --

1 ATTORNEY PROKOP: We'll get that before
2 we -- we'll get that before we complete the
3 transaction regarding the easement. The County
4 won't -- the position of the County on this has
5 always been that they won't talk to us until we
6 can show them that we have the easement in hand
7 about to be -- and about to be delivered with the
8 consent of all parties that are involved.

9 Once we get the consent of everybody and we
10 can demonstrate that we are ready to move ahead
11 with the easement, then the County will complete
12 this and, I believe, obligate themselves to what
13 needs to be done.

14 MR. WANG: And who is the one, who is the
15 County Attorney doing this, since Mr. Brown is
16 not there anymore, or he's doing something else?

17 ATTORNEY PROKOP: I think it's going to --
18 I'm hoping that it's going to be Amy Keyes. So
19 Amy Keyes is a new appointment where she's --
20 she's in charge of all Intergovernmental
21 Relations. And I'm hoping we can go through her,
22 because she's very -- she's demonstrated to be
23 very reasonable.

24 MAYOR VEGLIANTE: She's also -- she's also
25 like in front of every meeting each day. She

1 represents the County's Office and she's very
2 effective, she's a very reasonable and effective
3 woman, so I'm very encouraged by that.

4 MR. WANG: Thank you.

5 MAYOR VEGLIANTE: Okay. Anybody else got
6 anything? Come, this is it, this is the time,
7 we're all here.

8 MR. MUELLER: Hi, Gary.

9 MAYOR VEGLIANTE: Yes.

10 MR. MUELLER: It's Rich and Jill Mueller. Hi.

11 MAYOR VEGLIANTE: Hi, Rich.

12 MR. MUELLER: Can you kindly mention that
13 this record-setting sales transaction involved
14 someone who had rented in the Village before?

15 MAYOR VEGLIANTE: Yes. As a matter of
16 fact, it was brought to my attention that the
17 person who bought the \$6 million home was someone
18 who rented many seasons in our Village. And then
19 it was brought to my attention that of the last
20 six or seven sales, most of them were by people
21 who have rented in the Village. So it does
22 provide the Village with the type of purchaser
23 that had the ability to spend the right price for
24 these beautiful homes. It's been a big -- it's
25 been a big -- that's a monster sale. I mean

1 6 million bucks is more than any house by far. I
2 think the record before that was only -- was
3 4 1/2 million, nearly 5 million. My wife made
4 that sale, so I'm very happy to be part of it.
5 But now this one was 6 million, kind of -- kind
6 of blows it away, but I'm very happy to see it
7 happen. And there are two more houses now that
8 are in that range and they're getting a lot of
9 action, people are looking at them. You know,
10 we've -- we've become very valuable. People want
11 to be in West Hampton Dunes because of its
12 proximity to the City and Up-Island, and it's
13 really been working well for us.

14 MR. MUELLER: That's great to hear,
15 especially, you know, with all the challenges
16 that we're going through right now.

17 MAYOR VEGLIANTE: Yeah, it seems a few.

18 MR. MUELLER: Seems like renters are
19 providing an essential service, no pun intended,
20 as certainly normal times. Thank you.

21 MAYOR VEGLIANTE: Yep.

22 MR. ALVILLAR: Any idea if the person
23 rented for the long term or he was a weekend
24 renter?

25 MS. BRAATEN: Who is this?

1 MAYOR VEGLIANTE: I'm sorry. And, Dave,
2 could you just tell the Stenographer who you are?

3 MR. ALVILLAR: Yeah. David Alvillar,
4 813 Dune Road. I just wanted to know if that was
5 a long-term renter or a weekend renter. And I
6 was also wondering if you could tell us what the
7 address was of the \$6 million sale.

8 MAYOR VEGLIANTE: The \$6 million sale is a
9 matter of public record, so it was 839, right?
10 839 Dune Road --

11 MR. ALVILLAR: Oh, okay.

12 MAYOR VEGLIANTE: -- was the sale. It's a
13 beautiful home.

14 TREASURER VEGLIANTE: 5.9.

15 MAYOR VEGLIANTE: What?

16 MR. ALVILLAR: It's very close to mine.

17 MAYOR VEGLIANTE: 5.9.

18 MR. ALVILLAR: It's very beautiful.

19 MAYOR VEGLIANTE: I'm sorry. I'm being
20 corrected by my realtor wife. It was 5.9. I'm
21 sorry, it wasn't quite \$6 million. But it was
22 839. It's a beautiful home, built by a great --
23 a great builder in the Village, and it really --
24 it was a very nice home.

25 But, Ed, your first question, as David, you

1 know that we discourage short-term rentals, but I
2 do believe it was a person who rented for two
3 weeks or more, not a long-term.

4 MR. ALVILLAR: Wonderful.

5 MAYOR VEGLIANTE: Not a summer rental.

6 MR. ALVILLAR: That's great. That's great.

7 MAYOR VEGLIANTE: Yeah, it's been --

8 MR. ALVILLAR: Thank you.

9 MAYOR VEGLIANTE: It's been very nice.

10 I don't know if any of you have heard, but,
11 you know, there -- early on in this COVID
12 disaster, the East End Mayors and Supervisors, we
13 have a group, and they -- we meet every month.
14 But one of the first things they did early in
15 March, they sent a notice out to all the Mayors,
16 "Please sign this document," and it said,
17 basically, imploring Governor Cuomo to stop the
18 Manhattan -- the summer people from coming out to
19 their homes. So I quickly wrote back. I said
20 not only will I not sign it, I'm very much
21 opposed to this kind of conversation, because,
22 you know, for a long time we've been victims of
23 that bias against the so-called summer people,
24 winter people.

25 And I expressed to my colleagues and my

1 fellow Mayors and Supervisors that if they want
2 to extend that kind of prohibition upon the
3 people that they feel are not the real community,
4 then they should relieve them of nine months of
5 their taxes, and they could pick up the school
6 taxes and see how they liked it. Of course, it
7 was not well received by my colleagues, but I
8 continue to take that position.

9 So we welcome our residents out here. We
10 are all residents of this community. There are
11 no such thing as a summer resident and winter
12 resident. Unless we're all willing to give them
13 nine months of the year free taxes, I don't see
14 why they could be even considered.

15 So I just want to let you know, there's
16 still that bias out there, and it's -- and it
17 was -- it's still prevalent. I mean, on the
18 County conversations with the County Exec I hear
19 it all the time, you know, the summer people are
20 coming out, they're buying all our groceries out
21 of the grocery -- it's outrageous, but it still
22 exists, but does not exist in West Hampton Dunes,
23 I just want you all to know that.

24 MR. MUELLER: Good for you, Gary.
25 Rich Mueller again. Governor Cuomo reminded

1 Governor Raimondo that it was also
2 unconstitutional.

3 MAYOR VEGLIANTE: That's right. Cuomo's
4 actually been pretty good on this. He wouldn't
5 take the bait from the document. They did
6 actually send the document up to the -- up to the
7 Governor's Office asking him that, and he would
8 not take the bait, he wouldn't even address it.
9 As a matter of fact, Steve Bellone has been good
10 as well, he also would not entertain that kind of
11 conversation. So we do have some support by some
12 levelheaded people.

13 MR. MUELLER: Thank you.

14 TRUSTEE EFF: Gary, are we making -- are we
15 making or do we need to make any special
16 provisions regarding COVID-19 as it relates to
17 the increase in the summer traffic and occupancy
18 and so forth?

19 MAYOR VEGLIANTE: Basically, our laws are
20 in place that will protect us. I mean,
21 overoccupancy is always a problem and we've
22 worked very hard. We don't have -- really have a
23 problem with what they call -- considered group
24 rentals.

25 TRUSTEE EFF: Right.

1 MAYOR VEGLIANTE: So, no, our guys are well
2 protected. We have -- we have PPEs. We're well
3 staffed. The County's been very helpful in
4 getting us some stuff.

5 I don't know if Brian's still on. I know,
6 Brian, you had a good supply and you were hoping
7 to get a few more. Are you on, Brian? He may
8 have left.

9 ATTORNEY PROKOP: He's muted.

10 MAYOR VEGLIANTE: But we had a good supply
11 on hand. I think he could use a couple of more,
12 you know, the PPEs. But he put into the County
13 and they've been responsive. But we're okay,
14 John. Thank you.

15 TRUSTEE EFF: All right.

16 MS. MUELLER: Hey, Gary.

17 CLERK SADELI: Oh, unmuting.

18 MAYOR VEGLIANTE: Yes.

19 CLERK SADELI: Brian is on.

20 MS. GREEN: Kathleen Green at 852. One of
21 the -- we have a big problem with internet out
22 there. The only provider is Optimum.

23 MAYOR VEGLIANTE: Yeah.

24 MS. GREEN: We've had a lot of problems
25 with them. Is there any way that we can entice

1 some other internet service to come out there?

2 MAYOR VEGLIANTE: You know, I've tried that
3 in the past, Kit. I'll, hopefully -- I'll see
4 what we could do, and maybe we could try it
5 again. There's a little more competition out
6 there now.

7 MS. GREEN: Yeah, because Optimum is like
8 the only game in town.

9 MAYOR VEGLIANTE: Yep.

10 MS. GREEN: We've had some really bad
11 problems with them overcharging and --

12 MAYOR VEGLIANTE: Yep.

13 MS. GREEN: -- charging us for months after
14 we've already turned back equipment. And the
15 only other internet is the satellite dishes and
16 they're not nearly good enough.

17 MAYOR VEGLIANTE: No, they're not good.
18 Well, Verizon is not interested, FIOS doesn't
19 want to come out, but there may be other
20 providers. I'll see what I could do.

21 MS. GREEN: Yeah, that would be great.

22 SERGEANT HENNIG: Gary, Brian. I'm on, I
23 couldn't unmute. Yeah, the County has been
24 excellent, but we also put in for a grant through
25 one of our normal equipment providers who is

1 specifically trying to provide small agencies
2 like ours with equipment as well. It looks like
3 they approved to send us some more equipment. So
4 we definitely have what we need for now, but we
5 have more coming, so we're in a good spot.

6 And just a little side note about FIOS.
7 FIOS hasn't even come across the bridge yet. A
8 lot of residents have been trying to do that.
9 Until they across the bridge and actually bring
10 it onto Dune Road, it's going to be a tough
11 fight. But we would all love to see somebody
12 come in and compete with optimum, because they
13 are horrible.

14 TRUSTEE EFF: Joe.

15 SERGEANT HENNIG: And that could be on the
16 record.

17 TRUSTEE EFF: Joe, isn't -- isn't our
18 negotiations with -- for the franchise coming up
19 soon?

20 ATTORNEY PROKOP: Yes.

21 TRUSTEE EFF: Okay. So this would be
22 important to note this in terms of customer
23 satisfaction with what we currently have right
24 now. So it maybe a good leverage point for us.

25 MAYOR VEGLIANTE: Yeah.

1 ATTORNEY PROKOP: Well, we, under the law,
2 under the franchise laws in the state, we have
3 the right to object to the franchise based on
4 lack of --

5 TRUSTEE EFF: Right. That's why I'm
6 bringing it -- yeah, that's exactly the point.

7 ATTORNEY PROKOP: Maybe we should do that.

8 TRUSTEE EFF: Yeah.

9 TRUSTEE GOLDFEDER: Yeah. Well, remember,
10 they're going to -- if they bring in FIOS,
11 they're going to have to bring it in underground,
12 because it's fiberoptic. So what's left in the
13 Village, there's is very few on the pole copper
14 appliance. And I'm sure there's probably maybe a
15 half a dozen and that's it, and that's mostly for
16 probably alarm systems and nothing else, as a
17 thought.

18 ATTORNEY PROKOP: Okay.

19 MAYOR VEGLIANTE: I want to remind our
20 residents that this year is an election year in
21 the Village. I'm up, Mike is up, Barry's up.
22 You have to be registered in the Village, not
23 in -- not in anywhere else. So if you're
24 interested in voting, come on out, get registered
25 at the Board of Elections. I don't even know if

1 they're open, Joe. Is the Board of Elections
2 open?

3 ATTORNEY PROKOP: No. You know what,
4 they're open with a skeleton crew and --

5 MAYOR VEGLIANTE: What else is new? But --

6 ATTORNEY PROKOP: Literally a skeleton
7 crew.

8 MAYOR VEGLIANTE: Well, I just want to let
9 everybody know, our election is scheduled for
10 June 19th, but I believe that's going to be
11 delayed a little bit, because they haven't even
12 held the March elections yet. So we'll see what
13 happens. I'll keep you all posted. And,
14 basically, I don't think anybody's running
15 against the Board that's currently running. But
16 you all have the right to do that, just get the
17 petitions signed and see.

18 CLERK SADELI: We don't even know -- not
19 right now, they're not even allowed to petition.

20 MAYOR VEGLIANTE: Right. Right now, there
21 are no petitions available, because everybody's
22 got to social distance, so you really can't go
23 door to door and get a petition signed. But
24 they're looking at getting, getting that done, so
25 we'll see what happens. I'll keep you all

1 posted. But I believe right now our Board will
2 be running unopposed.

3 Anybody got anything else?

4 UNKNOWN SPEAKER: Everybody that buys in
5 Westhampton --

6 MS. BRAATEN: I'm sorry, who is this?

7 UNKNOWN SPEAKER: -- has to go before the
8 Board?

9 UNKNOWN SPEAKER: Sure.

10 MS. BRAATEN: Angela?

11 UNKNOWN SPEAKER: It's not a -- that's a
12 co-op, Mom.

13 UNKNOWN SPEAKER: I see.

14 CLERK SADELI: Okay. So I unmuted
15 everybody, so I can hear everyone's conversation,
16 and that's fine.

17 (Laughter)

18 CLERK SADELI: But if there's no other
19 comment, we're going to end the meeting here.

20 ATTORNEY PROKOP: So we need a motion to
21 adjourn into Executive Session to discuss a legal
22 matter.

23 MAYOR VEGLIANTE: Make a motion?

24 TRUSTEE EFF: I'll make the motion.

25 TRUSTEE CRAIG: No, I just -- I just got a

1 hold of Gary Trimarchi and he's going to join
2 Executive Session.

3 MAYOR VEGLIANTE: Okay. Does he have the
4 number?

5 CLERK SADELI: Yeah.

6 TRUSTEE CRAIG: Yeah.

7 TRUSTEE GOLDFEDER: Okay.

8 MAYOR VEGLIANTE: Okay, guys, thank you
9 very much.

10 (The meeting was adjourned at 8:18 p.m.)
